I had been living and teaching students in South Korea for 17 years from 2003 to 2020. Through this teaching experience which included students as young as 5 up to a classes of doctors over 40, I can understand many different voices, tones, and accents. I have been able to refine my teaching style to suit the age of the students. I find that fun and interesting lessons provide an experience that allows the students to learn without realizing they are learning. This system is especially beneficial to those students who either have a difficult time or just do not want to learn.

My photos have been featured in National Geographic, Lonely Planet, CNN, the Daily Mail in London, England just to name a few.
